IN CASE OF CONTACT, IMMEDIATELY FLUSH EYES WITH COPIOUS AMOUNTS OF WATER FOR AT LEAST 15 MINUTES.

EXTINGUISHING MEDIA

SUITABLE: FOR SMALL (INCIPIENT) FIRES, USE MEDIA SUCH AS "ALCOHOL" FOAM, DRY CHEMICAL, OR CARBON DIOXIDE. FOR LARGE FIRES, APPLY WATER FROM AS FAR AS POSSIBLE. HANDLING

USER EXPOSURE: DO NOT BREATHE DUST. AVOID CONTACT WITH EYES, SKIN, AND CLOTHING. AVOID PROLONGED OR REPEATED EXPOSURE.

STORAGE

SUITABLE: KEEP TIGHTLY CLOSED. KEEP AWAY FROM HEAT AND OPEN FLAME. STORE IN A COOL, DRY PLACE.

ENGINEERING CONTROLS

SAFETY SHOWER AND EYE BATH. MECHANICAL EXHAUST REQUIRED.

PERSONAL PROTECTIVE EQUIPMENT

RESPIRATORY: USE RESPIRATORS AND COMPONENTS TESTED AND APPROVED UNDER APPROPRIATE GOVERNMENT STANDARDS SUCH AS NIOSH (US) OR CEN (EU).
