DERMAL EXPOSURE

IN CASE OF CONTACT, WASH SKIN IMMEDIATELY WITH SOAP AND COPIOUS AMOUNTS OF WATER. CONSULT A PHYSICIAN.

FLASH POINT:

EXTINGUISHING MEDIA

SUITABLE: FOR SMALL (INCIPIENT) FIRES, USE MEDIA SUCH AS "ALCOHOL" FOAM, DRY CHEMICAL, OR CARBON DIOXIDE. FOR LARGE FIRES, APPLY WATER FROM AS FAR AS POSSIBLE. USE VERY LARGE QUANTITIES (FLOODING) OF WATER APPLIED AS A MIST OR SPRAY; SOLID STREAMS OF WATER MAY BE INEFFECTIVE. COOL ALL AFFECTED CONTAINERS WITH FLOODING QUANTITIES OF WATER.

METHODS FOR CLEANING UP

SECTION 7. ----- HANDLING AND STORAGE-----

HANDLING

USER EXPOSURE: AVOID CONTACT WITH EYES, SKIN, AND CLOTHING. AVOID FORMATION OF DUST AND AEROSOLS. PROVIDE APPROPRIATE EXHAUST VENTILATION AT PLACES WHERE DUST IS FORMED. NORMAL MEASURES FOR PREVENTIVE FIRE PROTECTION.

STORAGE

SUITABLE: KEEP TIGHTLY CLOSED. KEEP AWAY FROM HEAT, SPARKS, AND OPEN FLAME. STORE IN A COOL DRY PLACE. HYGROSCOPIC. STORE UNDER INER GAS. LIGHT SENSITIVE. AVOID DIRECT SUNLIGHT. RECOMMENDED STORAGE TEMPERATURE: 2 - 8 °C.

ENGINEERING CONTROLS

SAFETY SHOWER AND EYE BATH. MECHANICAL EXHAUST REQUIRED.

PERSONAL PROTECTIVE EQUIPMENT

RESPIRATORY: WHERE RISK ASSESSMENT SHOWS AIR-PURIFYING RESPIRATORS ARE APPROPRIATE USE A DUST MASK TYPE N95 (US) OR TYPE P1 (EN 143) RESPIRATOR.
